


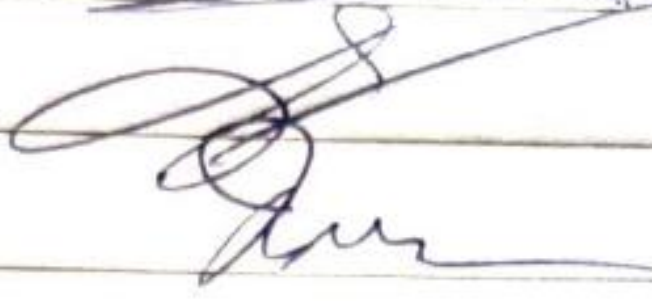
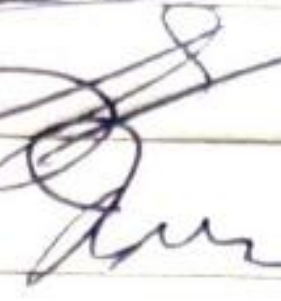


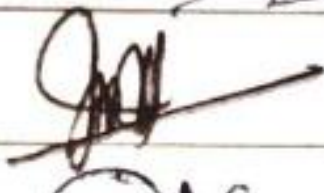





Minutes of the Board of Studies meeting held on 1.1.2015 at 10am.

* For Msc courses the mark distribution shall be as follows.

A part 5/8 3 marks each = $5 \times 3 = 15$.

B part 4/6 5 mark each, problems & derivations
= $4 \times 5 = 20$.

C part 4/4, 10 marks each, Essay type Questions
= $10 \times 4 = 40$ marks.

Total = 75 marks; 3hr duration.

Questions should be from each unit.

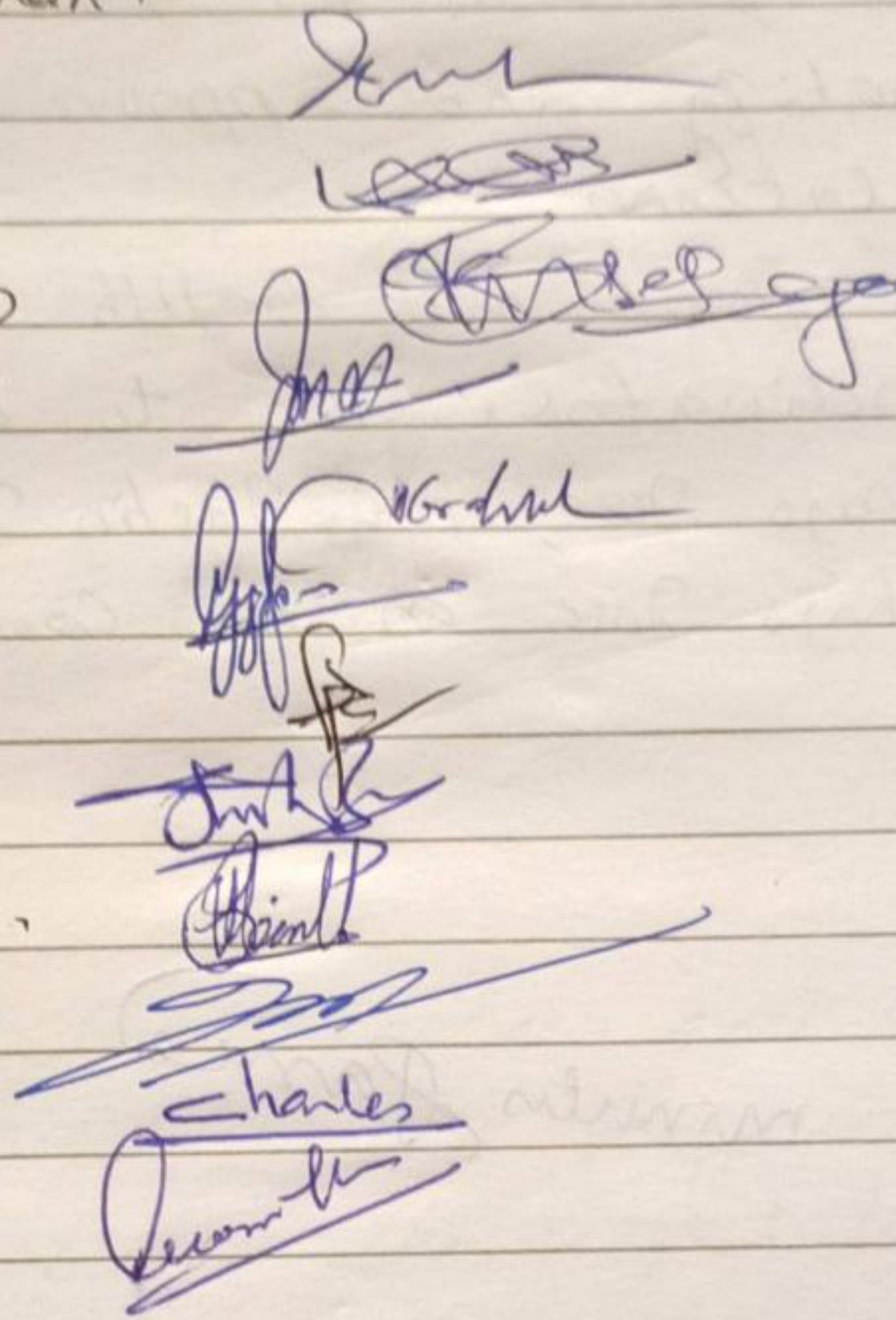

* Decisions regarding Mphil course.

- 1) To change the present grading system to mark system and then to grading system to '7' point scale as mentioned in the new guidelines.
- 2) To change the attendance calculation for getting the marks. However 75% of attendance is compulsory for appearing the examination.
- 3) For a theory paper total marks decided is 100. 70 marks for external examination and 30 marks for internal examination.
- 4) To award 50 marks in the second semester, based on a seminar and criteria specified in the guidelines before the submission of the final mphil thesis.
- 5) To appoint Dr. Siby Kurian as the new co-ordinator of the mphil course for the year 2016-2017.

Decisions regarding BVOC Course.

- 1) To start the classes for the BVOC course 2015 on first week of January 2016, as per the syllabus already approved and guidelines issued by the college and central government.
- 2) To fix the eligibility for applying the course as a pass in +2 from any science stream.
- 3) To satisfy and approve the corrections in the BVOC regulations.
- 4) To appoint Dr. Sajith Mathew as the course co-ordinator. Also to appoint Dr. Jacob Mathew, Dr. Crijo Jose, Mr. Justin John, Dr. Jeshy Jose and Dr. Lijo Jose as the committee members.

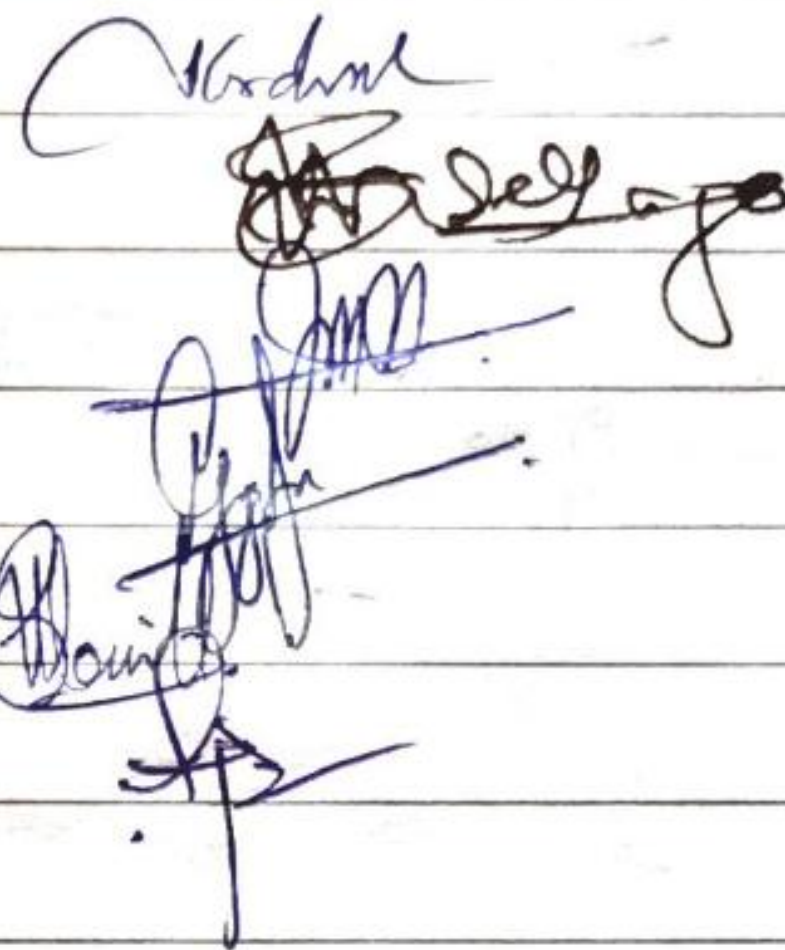

Discussion regarding Bvoc course.

To make the following change in the physics syllabi of the Bvoc industrial chemistry course. The practical component of the physics papers in 1st and 2nd Semester are removed as practical component in Bvoc course is required only for the core papers.

As per the original regulation the practical examinations for the general physics lab and computer applications lab are to be conducted at the end of odd semesters. To facilitate the exist of students after each semester if they wish to do so, these two practical examinations will be held at the end of each Semester. The meeting came to a close by 4.30 PM. The same is applicable in all other semesters. The endor credit courses to boost the performance level and additional skills

offered by the physics department in introduction to maths lab. This add on course consisting of 36 hrs of classes earns two credits to the students. The syllabus components of external and internal evaluation and grades on a 7 point scale based on the total percentage of marks obtained was studied and discussed in detail and approved. This extra credit system for BSc UG programme comes into effect on 2017 admission onwards.

The On Job Training (OJT) and Hands on training (HOT) areas to be evaluated by an internal examinee duly appointed by the controller of examinations. The credits were modified to meet the requirements given in UGC guidelines for BVoc course.

② For each theory paper in Mphil programme a candidate should score ^{at least} 40% marks for pass in that paper.

A conversion formula was approved by the board of studies to enable the conversion of raw marks obtained into corresponding grades. After the fruitful discussions the above amendments were forwarded to the academic council. The meeting came to a close by 4.30 pm.
