- Include introductory courses in the first semester, courses related to the social work methods in the second semester and more specialization oriented and advanced courses in the third and final semesters respectively. As per this the structure of the syllabus has been rearranged as follows:
 - Semester 1 : An introduction to social work profession and education, Understanding and addressing social problems in Indian context, Human growth and development, Theories, Models and Perspectives of social work, Basic Research methodology and statistics, Field Work Practicum 1.
 - Semester 2: Working with individuals and groups, Community organisation and Social Action, Psychological base for social work practice, Administration of human development organizations, Social Work Research, Field Work Practicum 2.
 - Semester 3: Participatory programme planning and management of development projects, Theory and practice of counselling, Specialization courses CD: Urban, rural and tribal community Development, Environment and Disaster Management, Community Health and Social Work. Specialization Courses MP: Psychopathology and social work, Medical Social Work, Health Care Administration and Community Health. Field Practicum 3.
 - Semester 4: Social Legislation, Contemporary Social Work Practice, Specialization courses CD: Social Entrepreneurship for development practitioners, Economic Development Theory and Practice. Specialization Courses MP: Social Work Intervention in the field of mental health, School Mental health and social work practice. Field Practicum 4.
 - The panel of question paper setters for the fourth semester MSW examination and panel of evaluators for the second and fourth semester MSW examination presented before the board of studies were approved by the Board of studies.





1. Increasing the total credit of MSW Programme to 90 to equate it with the new MG University Syllabus.

Resolutions

The following resolutions were taken in the Board of Studies Meeting:

1. Increase the total credit of MSW Programme to 90 by adding one credit each for the field work practicum in all the four semesters (the credits for field work practicum was 5 in each semester and it is increased to 6), giving 5 credit to the final internship in fourth semester which was an audited course earlier, and adding one credit to a specialization course which was credited two in fourth semester for both the specializations. With this effect there won't be any audited course for the MSW Programme.
2. Decided to change the name of a specialization offered by the Department from "Rural, Urban and Tribal Community Development" to "Community Development".
