



3. Principal pointed out the need for following the code conduct by teachers and administrative staff, I their meetings,

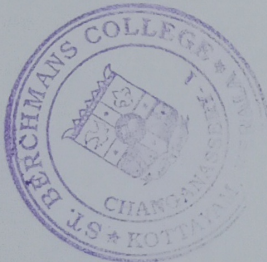
